On 11 November 2023, we are changing the name of the **Adviser Advantage** Super & Investments portal to **Adviser Online**. The current name of Adviser Advantage will continue to be used by Zurich Financial Services Australia in relation to their insurance offer only.

## HOW DOES THIS AFFECT YOU?

Importantly, there are no real changes to how you deal with us, it's simply a name change, and your login details remain the same.

The only exception is if you need to order printed documents. In this case, the first time you login to the renamed Adviser Online portal and select 'Printed Publications and Forms', you will be prompted to set up a new login.
