## What are the changes?

### What are the changes?

The Risk Profile in each investment option outlined in the Investment Choice Guide has been updated to reflect an industry best practice guidance known as the Standard Risk Measure.

#### Standard Risk Measures

Standard Risk Measures allow investors to compare investment options that are expected to deliver a similar number of negative annual returns over any 20 year period. We have assigned a risk band number and label (please see table below) to each investment option based on a model developed by an external consultant in accordance with industry guidelines. The Standard Risk Measure is not a complete assessment of all forms of investment risk, for instance it does not detail what the size of a negative return could be or the potential for a positive return to be less than an investor may require to meet their objectives.

Further, it does not take into account the impact of administration fees and tax on the likelihood of a negative return. Investors should still ensure they are comfortable with the risks and potential losses associated with their chosen investment fund(s).
