Investment objective

The fund targets a stable return in excess of inflation over the medium term.

Investment strategy

The fund aims to deliver a real return of Australian CPI + 2.0% p.a. over a rolling three-year period. The fund adopts a 'relative value' investment strategy to access a much broader range of fixed income return sources that are independent of the level or direction of interest rates. This strategy aims to combine pure relative value return sources with risk management strategies to provide returns that are independent of the direction of interest rates and broader market fluctuations. The Manager is a longer term, fundamentally driven, value investor with a focus on liquidity and diversification.
