Following the merger with Janus Capital Group, the investment management company, Henderson Global Investors, has changed its name to Janus Henderson Investors. As a result, the following investment funds offered through OneAnswer Investment Portfolio and OneAnswer Frontier Investment Portfolio have changed their name as follows:
