The balanced nature of the fund generally provides an equal exposure to growth assets such as property, Australian and international shares and alternative assets and defensive assets such as fixed interest and cash. A mix of passive, factor-based and active investment managers may be selected to manage the assets of the fund providing differing yet complementary investment styles to achieve more consistent excess returns. The fund is authorised to utilise approved derivative instruments for risk management purposes and investment efficiency. Please note that derivative instruments cannot be used to gear the fund's exposure. The underlying managers may utilise strategies for the management of currency exposure. It is the strategy of the fund that international currency exposure may be hedged. The fund has the capacity to change the level and nature of any currency overlay or allocation to underlying managers to manage currency risk.

Market and portfolio review

During the June quarter we made a change to our global shares strategy. Life Cycle Investment Partners ("LCIP") were appointed replacing Royal London Asset Management. LCIP utilise a 'corporate life cycle' approach to investing which is differentiated from many other global share managers. There were very strong returns in Australian shares (8.6%) and global shares (5.5%). The exposure to global listed property (+2.0%) and global listed infrastructure (+1.6%) generated positive returns. Exposure to fixed interest and private debt contributed positively to performance. The diversified fixed interest strategy returned +2.4% and private debt returned +2.3%. There was weak performance in unlisted property (-1.7%). In Australian and global shares there was weak performance from some of the underlying managers.

Future investment strategy

The Fund will continue to be managed in accordance to its objectives and strategies.
