The fund is authorised to utilise approved derivative instruments for risk management purposes and investment efficiency. It is the strategy of the fund that international currency exposure may be hedged. The fund has the capacity to change the level and nature of any currency overlay or allocation to underlying managers to manage currency risk.

Market and portfolio review

There were no manager changes during the quarter. The alternatives portfolio outperformed, with Intermediate Capital Group continuing to provide outsized returns. The diversified fixed interest portfolio outperformed, with Brandywine, Invesco and Ardea outperforming. The private debt portfolio outperformed, with all strategies outperforming. The Australian shares portfolio underperformed, with Acadian, Northcape, Quest, Antares and OC Mid cap underperforming. The unlisted property portfolio underperformed during the quarter due to a write-down. Although emerging markets outperformed developed markets, the underlying managers underperformed
