### Additional payment to your OneAnswer Frontier Pension account

We're writing to you regarding your previous investment in the OnePath Capital Guaranteed Fund (the Fund), which was redeemed as part of the transfer of your OneAnswer Pension account to OneAnswer Frontier Pension in June 2023.

After the transfer of your account, the final interest rate for the 2022/23 financial year was declared by Zurich Australia Limited (Zurich) and paid to other investors who remained invested in the Fund.
