

Updated Standard Risk Measures

The Standard Risk Measure (SRM) for each investment fund offered through the OneAnswer products (see below under 'Which products are impacted?') is assessed annually by an external consultant who has calculated the SRM using a model designed to meet industry guidelines, allowing investors to compare investment funds that are expected to deliver a similar number of negative annual returns over any 20-year period.

The Standard Risk Measure is not a complete assessment of all forms of investment risk, for instance it does not detail what the size of a negative return could be or the potential for a positive return to be less than an investor may require to meet their objectives.

Further, it does not take into account the impact of ongoing fees and tax on the likelihood of a negative return. Investors should still ensure they are comfortable with the risks and potential losses associated with their chosen investment fund(s).

As a result of the assessment, the investment funds in the table below have changed their SRM rating from what was disclosed in the OneAnswer Investment Funds Guide (IFG) dated 2 May 2016.
